PII is only used within the Office for OS Data Guardian Program and Management Training. There is no plan to share PII.

PII will not be shared outside the Office for OS Data Guardian Program and Training Management.

PII is only maintained by team members of OS Data Guardian Program and Training Management Office. It is stored on the user's (account creator's) Government Furnished Equipment (GFE).

**What other privacy risks exist and how will they be mitigated?**

No PII information is captured or shared from the survey respondents, other than the Survey Monkey account creator's information as previously stated. This Branch intends to check all privacy settings in Survey Monkey, so the respondents' PII is not captured.

All surveys are anonymous, meaning the identity of the person responding is not captured or discoverable by the Survey Monkey account holder. I am not aware of any other privacy risks.
